Ensure Teacher and Staff Safety

- Maximize space between students and between students and the driver on school buses, and open bus on school buses for students who may have inadvertently failed to bring one windows to the greatest extent practicable. Ensure each bus is equipped with extra unused face masks
- **=**: Minimize contact at school between students, staff, families, and the community at the beginning and end of the school day. Prioritize minimizing contact between adults at all times


